Student organizations are essential to the maintenance of the Civil Rights Movement and for the progress of African Americans.

always be engaged in stimulating conversations about politics and to know current events and history affect us. OLD WESTBURY ALUMNUS WINS AWARD

oshua Samuels, a resident of Floral Park, New York, and a recent graduate of SUNY College at Old Westbury, was recognized for his scientific research recently at the Annual Biomedical Research Conference for Minority Students (ABRCMS) in San Jose, California.

Having graduated in May 2012 with a degree in Biological Sciences, Samuels earned a presentation award in the Neuroscience category at ABRCMS for his project, titled "Increased Number of Synapses Modifies Drosophila Courtship Behavior." The presentation reflected research he conducted both at Old Westbury and at the Cajal Institute of the Spanish Scientific Research Council in Madrid. Samuels' research in Madrid was made possible through his participation in the Old Westbury Neuroscience International Program funded by the

NIH-National Institute for Minorities and Health Disparities.

ABRCMS is a national conference designed to encourage under-represented minority undergraduate and graduate students to pursue advanced training in the biomedical and behavioral sciences and provide faculty mentors and advisors with resources for facilitating students' success.

During the four-day conference over 1,704 students participated in poster and oral presentations in ten scientific disciplines in the biomedical and behavioral sciences. All undergraduate student presentations were judged and those receiving the highest scores in each scientific discipline were given awards during the closing banquet.

An Interview with Dinorah Martinez

Sometimes we are so involved and busy that we don't get a chance to get to know our SUNY Old Westbury staff members. Dinorah Martinez is the secretary of the Faculty Senate. She is also an artist who produces artwork in acrylic, watercolor, and oil. Dinorah Irene Martinez continues to create artwork in her Long Island studio. She became the artist that she is today because of the steady support and faith that she had surrounding her. She intensively practices her art, sketching constantly whether it is waiting for a bus or at the dentist. She enjoys working at Old Westbury and paints for self-fulfillment. Her artwork is featured in our library thanks to the Hispanic/Latino Cultural Center.

Question: Who or what inspired you to become an artist?

I had no other option but to learn the arts. My mother was an artist. She was constantly busy so she gave us colored pencils, sketch pads, pencils – we were dispositioned to paint. My mother watched us closely and watched us develop. (Una necesita a sus padres para ponerte en camino.) My mom entered me into the San Alejandro Visual Arts Academy in Havana at just the tender age of 13. I was the youngest one but everyone supported me and had a lot of faith in my success. I studied with the best art instructors available at that time in my native country, Cuba, where they trained me in a broad spectrum of visual art techniques, such as sculpture, mosaics, lithography, gravure, oils, and watercolors.

What made you emigrate from Cuba to the U.S.?

Every Cuban has a desire to leave. In order to be a painter I had to leave, I had no authority to officially declare myself as a painter. All my art materials I had to acquire



secretly. I was not allowed to have paint supplies. My only authority was to be a seam-stress. There was no opportunity, it was a different world, and it's hard to understand if you don't live through it. It was hard for me to even graduate high school. Exhibitions, etc. are only available here in the United States, I can paint on my spare time freely. The only advantage I gained from Cuba was my training, my training in the arts to become the painter that I am. (*Pero mi juventud fue puro lágrimas, una de tras al otro pero yo insistí a continuar*

What is your favorite visual art technique?

Paint, oil, acrylic and watercolors. Oil is the easiest for me to use. If I like to challenge myself I would paint landscapes using water color. I think it's good to explore all Δ



the possibilities and explore ones limits. So I went to go find myself and develop skills beyond my instruction of the classroom.

How long does it take you to creating a painting?

It depends on what I want to create. I was created a billboard in just two hours. If the elements, focus, balance, materials are available then it is possible to finish a complicated painting. Whether my project is simple or complicated I sometimes take a break and then come back to it to see what else I can add.

Does your art represent themes, thoughts or feelings?

Fundamentally any emotion that is good, anything positive. (*Paisajes, el ser humano saltana y bebes porque representan el futuro esperanza.*) I try to express happiness, joy or restfulness when I paint. I want to bring warm feelings to the viewer when they look at my paintings.

How would you describe your art?

"Unfinished" – I am never satisfied with my art and I am my worst critic. I always think of ways of how my art could be better. I work on many paintings at the same time, so I am never finished; I just start a new project. I always go back to retouch, add and finish...but I am never finished.

How do you want people to evaluate or interpret your art?

I want people to get the message of harmony, *grata sensaciones*. I am humbled and grateful when people can evaluate my art and are satisfied. It really makes me content when my art allows them to reminisce in bliss.

WALKING DEAD "FEVER"
















The Aftermath of the Chavez Inauguration

Although President Hugo Chavez has won his fourth term in Venezuela, his prolonged absence has caused the public to question his health due to cancer treatm ents, his absence from the inauguration ceremony, and the breaking news regarding corruption and an assassination plot.

In a New York Times article, William Neuman notes that if Chavez is not sworn in, the Venezuela constitution states that a new election will occur in thirty days. On Feb. 3, the BBC stated that Venezuela officials said that Hugo Chavez's health was "improving." The BBC also evaluated the circumstances regarding Chavez's good recovery from his recent cancer surgery in Cuba. As both sides accuse each other of corruption, the absence of Chavez appears to escalate this political instability.

The only way for the dissension



amongst the Venezuelan population and political arena to quiet down is if Chavez returns to be officially sworn in. However, impatient politicians may be forcing another election. The possibility of the Venezuelan public voting against the incumbent United Socialist Party of Venezuela is still possible.

Your funeral was so beautiful, I can remember like it was yesterday. All the children were dressed in white because Ms. Love, your mother told us to. It was in a big church and it was packed. I thought that everyone in the world was there supporting you as you had supported them. We had cried so much the night that you passed that I could not cry any more. However, I did cry one time, when Calvin, your sister's son explained that you were like a father to him and that he would miss you dearly. I think everyone cried after he said that because we could see the sadness in his face. Your funeral was a celebration because we celebrated the life you lived and the people you met along the way.

A couple of days before you passed away, we had a talk about how I should always be on my best behavior and that you said it was important for me to finish high school and go to college. It wasn't a Disney type of happy ending but at least it was an ending. Without a baby between them, there wasn't a forced link between her and Alex.

Months after the operation she was able to continue on with her small business, get her associates degree, and continue her education. All things she couldn't have pursued with Alex in her life. "At first I felt like a murderer," she said. "But as time passes, you realize that you weren't a murderer. You were simply a mother looking out for the best of your child and you knew you could not give him everything they deserve and more. I still feel sad and guilty when I think about having the abortion, but it is a lot better than feeling that way when your child is struggling with his life, having two parents that fight, and seeing his father hit his mother and his mother continuing to stay."


Here are some of Hitler's other


Identity Thief



Their jobs are to protect the public image of their clients, and to assure that their would-be scandals never see the light of day. Is the need to be the best indirectly killing baseball?

On January 29th, a report surfaced from the Miami New Times that alleged that a couple major league baseball players had received performance enhancing drugs from doctor Anthony Bosch who works at a clinic in Miami that had been indicted for providing them.

Among those implicated were Yankees third baseman Alex Rodriguez. This isn't Rodriguez's first scandal with Ped's. In 2009, after being implicated by Sports Illustrated, Rodriguez held a news conference at the Yankees spring training facility in Florida at which he admitted to using performance enhancing drugs from the years 2001-2003 while he was a member of the Texas Rangers.

Rodriguez wasn't the only player mentioned in the report. Nationals pitcher Gio Gonzalez headlined the list of people named in the report. Gonzalez finished third in the CY voting this year. Also named in the report was Texas Rangers outfielder Nelson Cruz. Additionally, former Yankee outfielder Melky Cabrera and catcher Yasmani Grandal were implicated in the report. Both of those players had positive tests for performance enhancing drugs at some point during the 2012 season giving the report a little bit of credibility.

If it feels like over the last five to seven years the topics of major league baseball and steroids and other performance enhancing drugs have gone hand at hand, it's because they have. When Jose Canseco first implicated guys such as Mark McGwire and himself, it opened a can of worms for baseball that has yet to be shut. Additionally, multiple congressional hearings have been held, and on top of that, two players, who without

allegedly using performance enhancing drugs would've been enshrined in the Hall of Fame in Cooperstown, were put on trial for lying to the grand jury about their use of the substances.

Since that time though, major league baseball has been front and center in attempts to combat this issue. They have adopted the strictest test for performance enhancing drugs among the four major sports. On top of that, starting this season they will begin testing for HGH (Human Growth Hormone) for the first time. They are the first of the four major leagues to introduce a test for this substance.

Analysts seem to think that as long as using the drugs provides a potential payoff for the player; they will be tempted and sometimes use the substance probably thinking they can beat baseballs tests. Last year, major league baseball busted seven people for use of performance enhancing drugs. Right now, the first penalty for players caught using a performance enhancing drug is a 50 game suspension. Some of those same analysts think a way to combat the issue would be to make the first punishment longer, possibly 100 games.

Steroids and other performance enhancing drugs are also beginning to impact that Baseball Hall of Fame in Cooperstown. Players from the steroid era in baseball who have been retired for a little while are now eligible for the Hall of Fame. This year's ballot, the most star studded in years was topped by Roger Clemens, Barry Bonds, and Mike Piazza. This year, was also the first time since 1996 that the BWAA didn't elect a single person to the Hall of Fame. The consensus seems to be that this happened for a multitude of reasons. The two biggest being that, a lot of writers who can vote

don't like to vote for guys on the first ballot, secondly the cloud of performance enhancing drugs among the candidates proved to be too much for any of them to get the votes.

Someone like former Mets catcher Mike Piazza unfortunately falls into this category. Piazza, who except for some rumblings has never been officially linked to any sort of performance enhancing drugs wasn't elected this year mostly because of guilt by association. It is widely believed that he will be elected within the next couple years however. Whereas, someone like Mark McGwire who has been on the ballot for a couple years now and has never gotten more then 20-25% of the vote will likely never get in. For those that aren't aware, 75% of the vote from the writers is what a player needs to get elected to the Hall of Fame.

The eligibility of players like Bonds and Clemens has drawn strong reactions from former players who are now Hall of Famers. In an interview in the beginning of January, former Yankee pitcher and Hall of Famer Goose Gossage had this to stay to CBS sports, "If any of these guys [ped users] ever get in, I probably will never go back to the Hall of Fame." If Gossage feels like that, it's not a stretch to think some of his colleagues feel like that because they share the mindset of people who played in that era.

It will be nice when baseball fans can just worry about baseball again instead of having the constant suspicion of whether or not someone is using something. Baseball has done a pretty good job trying to combat the issue; they need to do a better job though because the fans deserve it.

FORMER PANTHER NAMED TO ROSTER OF MAJOR LEAGUE CLUB

he Chicago Cubs have selected the contract of former SUNY College at Old Westbury Panther Robert Whitenack and added him them to the 40-man roster as the organization prepares to open for spring training.

Whitenack returned

to the mound in 2012 after undergoing Tommy John ligament replacement surgery in the summer of 2011. righthander The began the 2011 season 7-0 with a 1.93 ERA (13 Originally selected ER/60.2 IP) in 11 starts between Daytona and Tennessee, earning Southern League All-

Star honors, before being sidelined due to injury. Whitenack joined Daytona last May and went 1-6 with a 5.96 ERA (34 ER/51.1 IP) in 15 starts.

by the Cubs in the eighth round of the 2009 Draft, Whitenack is 19-18 with a 4.13 ERA (142 ER/309.1 IP) in 69 appearances (65 starts) in four minor league seasons with the Cubs. He became the first baseball player drafted out of SUNY College at Old Westbury.
