9/25/13 - Pt. arrived early for session & saw her date back into the office from basement area. Denied doing so even though I saw her. "You know you wanted me to do that. You put the idea in my hands. I saw that you told it. We talked about this. Pt. would have no responsibility for her actions. Yelling "You never cared for me. Tried to challenge that & had very positive feeling about her but that this was inappropriate and could not continue." "You're a dick" →
